The Farmer's Market will be held on 3rd Street between Clinton Street and the State Bank Motor Bank alley.

Once your application has been approved, you will be notified by the email contact listed. The approval committee has the right to decline any application.

Set up begins at 3:30 pm and must be completed by 4:30 pm.

Tear down may begin at 7:30 pm, unless you are otherwise notified by the committee.

Each vendor is responsible for having appropriate money/change through out the day, as well as their own set-up, tables, sunshade, electric, etc. Electricity is unavailable so please plan accordingly.

No vehicles are allowed within the event premises once set-up is completed.

We encourage the well-being and health of Defiance by having the most wholesome options available at the Farmers Market. If you provide chemical-free produce, additive free/preservative free foods, antibiotic/ hormone free meats/cheese, we will feature your business twice a month on the Facebook page. If your products contain additives, preservatives, or sprayed produce, you will be featured twice a farmers market season on the Facebook page.
